

MEMBER CONSENT TO ACCEPT ELECTRONIC DELIVERY OF E-STATEMENTS

Definitions. In this Agreement, the word “e-Statement” refers to your periodic Statement of Account and 1099-div and 1098. The words “you” and “your” refer to you, the Member of Comanche County Federal Credit Union (CCFCU). The words “we,” “us,” and “our” mean CCFCU.

Consent to Receive e-Statements Electronically. By clicking the “E-Statements” link from our web page <http://www.comanchecountyfcu.com/> then entering THE LAST 4 DIGITS OF YOUR Social Security Number of the primary member, e-mail address and account number, you can agree to accept online e-Statements and year-end tax statements for dividends earned, 1098 mortgage interest paid. E-Statements include transaction activity for all of your share accounts, which include savings, checking, certificates, loans, etc. You further agree that we will *discontinue mailing a paper statement* to you and will communicate with you electronically, as necessary. Each primary account will have a separate sign-on.

Your User ID will be your account number. Your USER ID and PASSWORD are confidential and should NOT be disclosed to others or recorded on documents or records located on or around your PC. You agree not to disclose or otherwise make your USER ID and PASSWORD available to anyone not authorized to access your account. You understand that if you reveal your USER ID and PASSWORD to anyone, you have authorized that individual to access information from any of your accounts which can be accessed by the USER ID and PASSWORD, regardless of whether that person is authorized to access these accounts by any means other than by use of the Service. If you fail to maintain security of your USER ID and PASSWORD and CCFCU suffers a loss, we reserve the right to terminate Service to you under the Agreement and Disclosure. CCFCU will not be responsible for any losses you suffer due to your failure to maintain the security of your USER ID and PASSWORD. If you forget your PASSWORD or are disabled due to the use of an incorrect PASSWORD you may reest thru the online link. We reserve the right to require written re-application for a replacement PASSWORD.

Requesting a Paper Copy of e-Statements. You may request a paper copy of your periodic statement received electronically under this Agreement by writing to Comanche County Federal Credit Union at 916 W. Gore Blvd, Lawton, OK 73501, e-mailing us at CCFCU@COMANCHECOUNTRYFCU.COM, OR contacting our Member Service Representative at 580-353-3755. You may also print statements from your computer. There is no fee for us to print your current statement for you at your request. E-statement will be available on the portal for up to 13 months.

Right to Withdraw Consent. You may terminate this Agreement at any time by writing to Comanche County Federal Credit Union at 916 W. Gore Blvd, Lawton, OK 73501, e-mailing us at CCFCU@COMANCHECOUNTRYFCU.COM, OR contacting our Member

Service Representative at 580-353-3755. There are no fees for requesting to withdraw your consent for e-Statements.

Hardware and Software Requirements. To access E-statements and retain documents, agreements and disclosures electronically you need Internet access, an Internet browser and Adobe Acrobat Reader. You are responsible for the set-up and maintenance of your home computer, which supports requirements of our E-statements. The minimum requirements to view your account statements electronically are Internet Explorer 5.5 or higher, or equivalent software; hardware capable of running this software; and a printer if you wish to print your e-Statements or the ability to store (save) your e-Statements electronically to your computer. These minimum requirements, required to access and use the system, may change without notice. We make no warranty or representation regarding the access speed that you will have now or in the future, as such is beyond the control of the Credit Union. Also these minimum requirements are likely to change as technology, software and other matters continue to evolve.

Change of E-mail Address. You should keep us informed of any change in your electronic mailing address. You may change your e-mail address by signing a change of address form at the credit union, OR through our web page <http://www.comanchecountyfcu.com/asp/emailsignup.asp> .
